At Redland Bay State School, our year 5 and year 6 students are encouraged to bring their own device to school for learning. Bring Your Own (BYO) device supports the delivery of 21st century learning. It enhances the learning process and prepares students for future studies and careers.



This booklet contains information related to appropriate device specifications, operating system requirements, required apps and behaviour expectations. The user agreement will be sent home in the first week of 2022 for parents and students to sign and return to their teacher, before your child's device can be connected to the school network.

Redland Bay State School:

- strongly recommends that families seek and provide their own warranty and insurance (accidental damage) protection
- strongly recommends that a protective case is used at all times
- requires that all devices accessing our network be registered with the school and that the user agreement is signed and adhered to
- will take all reasonable steps to connect private devices however it cannot take any responsibility if it is unable to connect a particular device
- will provide technical assistance for connectivity issues only
- insists anti-virus protection be installed and functioning at all times.

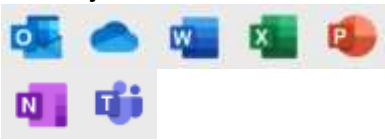

Redland Bay State School technical support will only be available to rectify connectivity and other school based technical issues.

Monitoring and Management of ICT resources, including Student-Owned Devices

All departmental ICT resources are the property of the Department, which reserves the right to monitor the use of these ICT resources. This right extends to student-owned devices connected to the Department's school network. The monitoring may include reading the content of files and emails, including personal files and emails, stored on departmental or student owned ICT resources. This also includes any material that has either been run or deleted from any personal computer, laptop, Netbook or mobile device and may involve the confiscation of the ICT resource for this purpose.

The Department has the lawful right to monitor your use of its ICT resources and may do so at any time without notice. The school may exercise its right to monitor the use of the school's ICT resources to:

- ensure that the systems and networks are functioning properly;
- protect against unauthorised access; and to
- ensure compliance with the Rules for Responsible ICT Use.

The Department may exercise its right to monitor the use of resources to:

- ensure that the systems and networks are functioning properly;
- protect against unauthorised use and/or access; and
- ensure compliance with the principles and procedures of departmental ICT use, as described in this Acceptable Use Agreement.

The Department's ICT resources will be monitored randomly and/or by exception (e.g. in response to complaints or investigations). The Director of Information and Technology Services can authorise monitoring. The Manager of IT Infrastructure can undertake the monitoring of departmental ICT resources.

The department restricts access to some material available via the Internet, but does not accept responsibility for any illegal, offensive, indecent or otherwise harmful material accessed on the Internet, nor for any loss arising from use of, or reliance on information obtained through its internet service or in relation to the reliability or quality of that service.

The Department does not accept responsibility for any damage or loss to student owned devices or accessories brought to school or connected to the Department's ICT resources.

Personally-Owned User Agreement

Students should read through this agreement **WITH THEIR PARENTS OR CARERS** to ensure both parties have a clear understanding of the expectations and requirements when bringing a personal device to Redland Bay State School and connecting to the school network.

As a student, I agree to:

- use my device for learning purposes only as directed by my teacher
- respect others when I talk to, and work with them online, and never write or participate in inappropriate online communication at home or at school
- never use my device to communicate with other students or people outside the school during school hours, unless teacher directed
- only use applications that are school approved
- never access the internet through 3/4G, hotspots, or other independent network connections
- never download apps through the school network unless instructed by a teacher
- never share links, searches, attachments or apps without teacher direction
- never photograph or record any student or staff member at school without your teacher's permission and the permission of the people in the image
- never record incidents involving students in the school or in school uniform
- never use NON-DEPARTMENTAL cloud-based storage services (e.g. iCloud or Dropbox) to store, send, access or share information
- ensure the battery is fully charged each day
- remember my school username and password for connectivity purposes.
- not place food or drink near the device
- protect the screen by using a protective cover and avoiding any pressure on the screen or lid

I understand that if I fail to abide by the terms of this agreement I will be excluded from accessing my device at school for a set period (see Table 1: Consequences of Misuse), and that my parents/carers will be notified to collect my device from School.

As a parent/ carer of a student using a Personally Owned Device, I agree to:

- accept responsibility for my child’s use of their device outside school hours,
- monitor my child’s appropriate use of social media and appropriate communication using the device
- responsibly choose and monitor my child’s use of any apps or programs not approved by the school as per this document
- ensure that explicit content and internet search links are not brought in on devices from home or shared with other students
- communicate with the class teacher any concerns or misuse of the device by my child
- communicate with the class teacher any incidents of misuse of a device by another student
- communicate with the class teacher the actions I have taken as a parent to deal with misuse and support the school actions as outlined in *(Table 1: Consequences of Misuse)*.

Redland Bay State School BYOD Parent Checklist

Preparing for your child to bring their device to Redland Bay State School



- Create an **Apple ID and Password** or **Microsoft Account**, if you haven't already got one (we advise you **NOT to tell your child** these details) to access and download apps from the App Store/Windows Store. You can choose to use an existing Apple id / Microsoft Account in order to share apps or set up Family Sharing <https://support.apple.com/en-au/HT201088>

- Discuss elements of the Redland Bay SS User Agreement with your child and ensure your child understands their expectations and your commitment

- Ensure that your child understands that they are **not to capture photo, video or audio unless advised to do so by their class teacher.**

- Ensure your child knows they **cannot misuse the device or engage in inappropriate communication both at home and at school using the device.**

- Have purchased a **protective cover and keyboard** for your child's device and considered a tempered glass screen protector.

- Loaded all the required apps** on your child's device as per the required apps

- Your child is aware of the login details, username and password, for the school network (ie, same as email xxxxxxx@eq.edu.au)

- Regularly update your child's device, (apps and operating systems) to ensure the latest versions are installed.
